Dear Support Family:

We, again, want to welcome you into the Rays of Sonshine family. We are confident of your desire to see long-term recovery established in your loved one. This, too, is our mission. Statistics prove that the longer an individual seriously pursues supervised support, the better the "chances" of success. With early stages of recovery being five to seven years, we are in the process of developing long-term supervised support: beginning with primary care residential recovery treatment (for up to a year), then progressing into long-term transitional living for as long as an individual needs a structured environment.

With these objectives, we solicit your help. We are a local mission and do not charge individuals who have no ability to pay. Because we are a mission, we depend on compassionate individuals such as yourself to help us accomplish our task: to help us help you.

It costs us \$135 per day, per client to maintain the quality of recovery treatment we have developed. Because your loved one has no insurance or means to pay for these services, we are asking you to financially invest in the continuance of this program -- financially invest in helping us continue to help your loved one, as well as other women who struggle with addiction.

More than 25% of the finances we need to continue must come from private individuals, businesses and churches. Without community involvement, we could not continue. Every single dollar makes a difference.

Enclosed is a pledge card. We are asking you to consider supporting us regularly in some way for at least one year: donations can be mailed, automatically deducted from your bank account, or arranged online through PayPal. Together we can make a difference -- together we can see broken lives restored, one woman at a time.
